1) The received quotations will be evaluated through Shopping Method of procurement in accordance with the World Bank's procedure set out in the "World Bank Procurement Regulations for IPF Borrowers (July 2016) revised November 2017 & August 2018 ("Procurement Regulations").

- The Taxes will be deducted according to the Government Rules.
