The **Government of Pakistan** has received credit from the International Development Association towards the cost of Sindh Resilience Project (Irrigation Component) and intends to apply part of the funds to cover eligible payments under the Contract for Works of Contract Package Nos. PK-SID-69711-CW-RFB-NCB-09, PK-SID-2969-CW-RFP-NCB-10 and PK-SID-2966-CW-RFP-NCB-11 Bidding is open to all bidders from eligible source countries as defined in the Guidelines: Procurement of Goods, Works and Non-consulting Services under IBRD Loans and IDA Credits and Grants by World Bank Borrowers” dated January 2011 (revised July 2014). (Procurement Guidelines)
2. The **Project Director, Sindh Resilience Project (Irrigation Component)** for each of Contract invites sealed bids from eligible bidders for the construction and completion of the following works

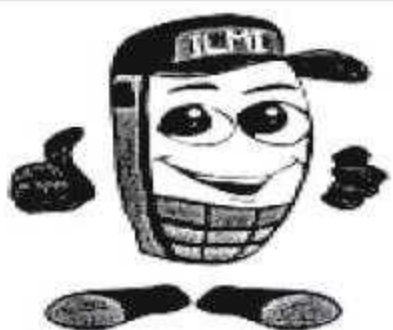
The Works for each of aforementioned Contracts are to be completed 364 days Partial or incomplete bids will be treated as non-responsive.

Bidders may bid for one or more of the above Contracts, including all items specified under each Contract. Bid evaluation and contract award will be made Contract-wise.

3. Bidding documents (and additional copies) may be purchased from Office of the Project Director, Sindh Resilience Project (Irrigation Component), Bungalow No. 125-B, Khayaban-e-Bahria, Defence Housing Authority Phase-VII, Karachi for a nonrefundable fee of Rs.3000/- (In words Rupees Three Thousand Only) for each set. Interested bidders may obtain further information at the same address.
4. Bids shall be valid for a period of 90 days after Bid opening and must be accompanied by bid security of minimum 2% (**in shape of Bank Guarantee**) of the Bid Price and shall be delivered to Office of the Project Director, Sindh Resilience Project (Irrigation Component) Bungalow No. 125-B, Khayaban-e-Bahria, Defence Phase-VII, Karachi on or before August 27, 2018 at time mentioned as above for each Contract. The bids will be opened at mentioned time for each Contract in the presence of the authorized representatives of the bidders who wish to attend.
5. The Procurement process will be conducted in accordance with the National Competitive Bidding (NCB) method in accordance with paragraph 3.3 of “Guidelines Procurement Of Goods, Works, And Non-Consulting Services Under IBRD Loans And IDA Credits & Grants by World Bank Borrowers (January 2011) (Revised 2014)”.
6. A pre-bid conference will be held at 12:00 hrs on 09-08-2018 for aforementioned contract packages at the office of the Project Director, Sindh Resilience Project (Irrigation Component), Bungalow No. 125-B, Khayaban-e-Bahria, Defence Housing Authority Phase-VII, Karachi. The purpose of the meeting will be to clarify site and various other issues and to answer queries on any matter that may be raised at that stage. All potential Bidders who obtained the Bidding Documents are invited to attend.
7. All bidders shall be required to submit with their bids, qualification information specified in the bidding documents. This information shall be used to establish through post-qualification whether the bidder is qualified to perform the work.
8. Bids are required to be submitted on item rate basis (not on the basis of Composite Schedule of Rates with percentage premium) and the rates and amounts (in Rupees) must be filled by the bidder for each item in the Bill of Quantities and provide a total price. Non-compliance may result in rejection of bid.
9. Bidders should give their best and final price in their bids as no negotiations are expected.
10. As provided in the bidding documents, bidders engaged in corrupt or fraudulent practices (including collusion/ pooling) will be declared ineligible, either indefinitely or for a stated period of time, to be awarded a contract financed by the World Bank.
