The Government of Sindh has received a "Credit" from the International Development Association (IDA) for **Sindh Resilience Project**, and it intends to apply part of the proceeds of this credit to payments for hiring consulting services for Feasibility Study of 30 Nos. of Small Dams in Water Scarce Areas of Sindh Province.

The Project Director, Sindh Resilience Project (Irrigation Component) invites eligible consultancy firms/joint venture(s) with specific and proven competence and experience to indicate their interest in providing the services. Eligible firm(s) should submit Request for Expression of Interest (REOI) in the English language along with relevant complete details of the qualifications and experience.

Interested consulting firms/joint venture(s) must provide information, indicating that they are qualified to perform above services e.g. Brochures, Registration of Firms, Detail of General Experience, description of similar assignments, values of previous assignments along with contact details of past clients for each assignment, experience under similar conditions, availability of appropriate professionals etc.

The shortlisting criteria are:

a) <b>General Experience:</b> The consulting firm should have completed at least three (03) assignments in Irrigation and Water Resources Management in last ten (10) years.	10
b) <b>Specific Experience:</b> The firm should have successfully completed at least three (03) assignments of similar scale and complexity in last 10 years.	45
c) <b>Social and Environment Management:</b> The firm should have Experience in preparing ESMF/ESMP/ IEE/EIA/EMMP & Land Acquisition & Resettlement Action Plan (LARAP) / Abbreviated Resettlement Action Plan (ARAP) etc.	20

d) Logistic capacity of the firm	10
e) Technically Qualified Staff covered under TORs	15

The consultants while submitting their Expression of Interest in association should clearly mention whether their association is a Joint Venture or Sub-consultancy. Moreover, Under JV, each partner must be qualified to take over the responsibilities and roles of any of the partners in case one of them fails to perform or withdraws. In case of association of lead sub-consultant, the Lead Firm must be clearly mentioned in the REOI. However, consultants are not required to submit JV Agreement at shortlisting stage. In case of Joint Venture maximum number of member should not be more than three.

A consulting firm(s) / Joint Venture(s) will be selected in accordance with the procedures set out in the World Bank's guidelines: Selection and Employment of Consultants by the World Bank Borrowers, **January 2011, (revised July 2014)**. The selection of the consultants will be made following **Quality and Cost Based Selection (QCBS) method**.
