The Government of Sindh has received a "Credit" from the International Development Association (IDA) for Sindh Resilience Project (Irrigation Component), and it intends to apply part of the proceeds of this credit to payments for hiring of consulting services for Impact Assessment of Small Dams constructed under the Sindh Resilience Project (Irrigation Component) in the Sindh Province.

The Project Director, Sindh Resilience Project (Irrigation Component) invites eligible consultancy firms/joint venture(s) with specific and proven competence and experience to indicate their interest in providing the services. Eligible firm(s) should submit Request for Expression of Interest (REOI) in the English language along with relevant complete details of the qualifications and experience.

Interested consultants will be expected to demonstrate evidence of their qualification to perform this assignment, in their profiles; in the areas covered by the Project. Firms should have a specific and proven competence and experience in Impact Assessment of Small Dams. Interested consulting firms must provide information indicating that they are qualified to perform above services (e.g. brochures, description of similar assignments, value of similar assignment); experience under similar conditions, availability of appropriate skill among staff etc. Consultants may associate to enhance their qualification. Consultants are encouraged to provide only materials that would be specific to the proposed services, and to avoid submitting generic promotional material. The shortlisting criteria are (i) Corporate Capacity (Core business and years of experience in same business for at least 10 years); ii) The firm should have successful completed at least 03 assignments of similar scale and size in last 10 years in the area of Impact Assessment of Dams; iii) Adequate Logistical capacity, as evident by established offices iv) technical and managerial capability of the firm.

The consultants while submitting their Expression of Interest in association should clearly mention whether their association is a Joint Venture or Sub-consultancy. Moreover, under JV, each partner must be qualified to take over the responsibilities and roles of any of the partners in case one of them fails to perform or withdraws. However, consultants are not required to submit JV Agreement at shortlisting stage. In case of Joint Venture maximum number of members should not be more than three.

A consulting firm(s) / Joint Venture(s) will be selected in accordance with the procedures set out in the "World Bank Procurement Regulations for IPF Borrowers Goods, Works Non-Consulting and Consulting Services Fourth Edition November 2020 under Consultant Qualification Selection (CQS) method.

Expression of Interest (EOI) must be delivered in a written form to the address below (in person or courier) by November 16, 2023, up to 1500 PST.
